INTERROGATORY NO. 16:

Describe Applicant's clearance, selection, and adoption of Applicant's Mark, including, without limitation, explaining why and how Applicant's Mark was chosen and describing any searches or reports relating to Applicant's Mark or the term "GAGE," and identify the three Persons most knowledgeable regarding the same.

RESPONSE TO INTERROGATORY NO. 16:

Applicant objects to this Interrogatory on the grounds that it calls for information that is protected by the attorney-client privilege and attorney work product doctrine, namely searches and reports relating to Applicant's Mark and the term "GAGE". Subject to the foregoing and without waiving the General Objections, which are incorporated herein by reference, Applicant states the following:

Applicant's Mark was selected by prior owner of Applicant's Mark, Radicle Cannabis Holdings Inc., based on the location of its first federally licensed cannabis facility, which was located off Gage Avenue North in Hamilton, Ontario, Canada. Applicant is entitled to "tack" its first use to the earliest use by its predecessor, Radicle Cannabis Holdings, Inc. Applicant's Mark was also selected due to its brevity, as it was thought that a short term made up of a few letters would be a more powerful and memorable brand. Applicant identifies Director Rami Reda and Marketing Director Graeme Davis as the persons most knowledgeable about the clearance, selection, and adoption of Applicant's Mark.

GENERAL OBJECTIONS

Applicant can and will demonstrate bona fide use and intent to use the GAGE mark that predates Opposer's alleged prior use. Since as early as 2006, Applicant has owned and operated domains that use and incorporate the GAGE mark, commencing with gagegreen.com, followed by gage.ca, gagecalifornia.com, gagecannabis.com, gagegreen.com, gagegrow.com, gagehemp.com, and gagelife.com, among others. Applicant, its predecessors in title and licensees have established GAGE as a leading cannabis brand in Canada, and has legally

operated in the U.S., chiefly in Michigan, with all required licenses and permits, including having opened five brick and mortar locations, with expansion plans including eight more stores in the Michigan area. On November 11, 2017, Applicant filed U.S. Trademark Application Ser. No. 87/695,693 on an intent to use basis (Section 1(b)) for the Applicant's Mark: GAGE.
